



## 2020 Rental Rates and Information

Amenities are booked on an hourly basis and require a two-hour minimum rental. The rental period must include any necessary set-up and clean-up time. Amenities can be booked no more than three months in advance of the reservation date. Only homeowners are permitted to reserve the Covered Pool Patio at each facility, as pool use is not permitted for non-residents, unless they are approved guests of current Candelas homeowners.

## Park Pavilions

Pavilions are available for rental at all six City of Arvada Parks in Candelas: Foxtail Pond Park, Cimarron Park, Sarah George Park, Maverick Mesa Park, Haystack Plateau Park, and Church’s Crossing Park. The rental rate is \$15 per hour, with a two-hour minimum, plus a refundable security deposit of \$100. Rentals only include the Pavilion area and do not provide exclusive use of other areas within the Park, as all Parks are for public use. Any turf rentals (i.e. Bouncy Houses) must be approved with Apex Parks & Recreation District prior to renting. Contact Lifestyle Director for more information.

### Other Information:

- Any intended pool use **must** be disclosed at the time of reservation. Residents are allowed up to six guests per day at the pool. Pool Party wristband packs (20 bands for \$50) may be purchased for your party, which allows you a total of 20 people at the pool pavilion – INCLUDING homeowners. All guests using the pool or pool deck must wear a wristband at all times during the rental.
- Payment of rental fees and security deposits is required **in full** at the time of reservation. Payments can be made by check or credit/debit card (a transaction fee is added to all credit card transactions). We cannot hold the security deposit checks, and you will get a refund the same way you paid (back to card, or with a mailed check).
- Cancellations may be made at any time for a full refund of the security deposit. Cancellations made 30 or more days prior to the event will receive a full refund of the rental fees; 14-29 days prior to the event will receive a 50% refund of rental fees; and less than 14 days prior to the event will forfeit the full amount of the rental fees.
