Distributions will be equal to the lesser of (a) the amount of actual out-of-pocket costs incurred by the Owner when installing QRES Improvements in or on his or her Home, or (b) such Owner’s pro rata share of the QRES Account (determined by dividing the amount of available funds, from prior end of month financials, in the QRES account, by the total number of eligible owners at such time (i.e., all Owners owning a Home that does not have QRES Improvements installed by a Homebuilder and who have not yet submitted a pending or approved application for a QRES Distribution), and subject to the following conditions:

- (A) Determination by the Sustainability Committee and approval by the Trustee in its sole discretion that the applicable expenditures qualify as expenditures for improvements that constitute QRES improvements;
- (B) Any limitations set forth in the disbursement strategy established by the Trustee pursuant to Section 6.2(b), and determination by the Trustee in its sole discretion that sufficient Distributable Cash exists to make such a QRES Distribution; and
- (C) Any other terms, conditions and limitations set forth in this Declaration or adopted by the Sustainability Committee.
